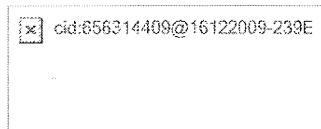

Further to our conversation yesterday and my e-mail of 14:19 today with its attachments, copied to you and forwarded again with this e-mail, Terry Ellames has told me that the intention is that letter and plan will not be distributed to members. This is apparently on the basis that this would mean other correspondence would also have to be put before members.
